

How a group purchasing organization (GPO) can help your organization prepare and rebuild. We live in a world where we're far more likely to worry about the present than the future. Your todo list is getting longer each day, and it probably seems more productive to handle immediate, more pressing needs instead of sitting down to map out plans for events that may not even occur. But what happens when a catastrophe, major or minor, strikes your organization without warning and you aren't certain of how to proceed? Maybe you have an outdated disaster preparedness plan that doesn't quite reflect the scope of your organization, or maybe no one in your organization has taken the time to build out such a plan. If your organization doesn't have a clear path forward in the wake of a disaster, you're left to either resolve the crisis with the limited supplies you have available or make rash purchase decisions that might not be either timely or cost-effective.









As of April 8, two confirmed weather or climate disasters with more than \$1 billion in losses have affected the Unites States in 2024. These two disasters resulted in the deaths of six people and had significant impacts on the economy. The annual average of disaster events resulting in \$1 billion in damages in the most recent 5 years is 20.4, meaning the United States can anticipate 18 or more major events to occur in the remainder of 2024. Such events could include droughts, hail, flooding, hurricanes, severe weather, tornadoes, wildfires, and winter storms, all of which can have devastating effects on the area they strike.

Aside from natural disasters, organizations operating out of physical facilities may also be

affected by more localized disasters like fires, pipes bursting, or structural failures.

Organizations and the individuals involved with them could also be heavily impacted by issues like workplace injuries, equipment-related accidents, theft, violence, or costs from cybercrime damages, which alone are predicted to reach \$10.5 trillion by 2025.

To ensure that your organization is ready to face disasters, natural or otherwise, you must focus on the three p's: plan, prepare, and practice. Take time to work with stakeholders to develop and distribute a comprehensive plan, perform concrete actions to prepare the resources you need, and practice your plan regularly so that you can identify and implement any necessary adjustments.



It's far more advisable for organizations to be proactive in their approach to disasters than reactive to ensure that an efficient strategy is in place. To appropriately plan for disasters, your organization must develop policy and procedural documentation to guide disaster response. Considering the variety of disasters that can befall an organization, it's never too soon to assess your current disaster preparedness documentation to identify any necessary improvements.

If you're realizing that you don't have such documentation or are worried that the documentation you do have is insufficient, creating a formal emergency operations plan (EOP) is a great first step in your disaster preparedness journey. Before you jump into EOP creation, though, take time to determine the types of disasters (natural and otherwise) that could affect your processes and physical resources as well as your employees and community. Performing an emergency response risk assessment can help identify the emergency situations that may pose the most risk to your organization's unique environment.



Designing Your First Emergency Operations Plan (EOP)

Successful disaster-related plans address your organization's internal needs first and encourage unity and coordination across a variety of stakeholders. There is no one "right" format for an EOP or strict requirements for what elements to include, though the Federal Emergency Management Agency (FEMA) does offer planning guides that you can download to get started. The important thing to ask of your EOP is whether it accurately reflects all facets of your organization and details processes for all stages of a disaster. For organizations taking their first stab at an EOP, FEMA recommends ensuring that the EOP is organized coherently, exhibits a logical progression between elements, remains consistent, can be adapted to unforeseen circumstances, and promotes coordination with stakeholders.


If your organization is just getting started with creating an EOP, consider outlining crisis communications plans, staff roles in a disaster, and supplier contacts. Crisis communications plans should be targeted at all relevant audiences like employees, customers, suppliers, management, and regulatory bodies and should include a robust contact list. For any staff members that are assigned a role, the role and its responsibilities should be communicated to those individuals in full. EOPs should also include information regarding data protection and backups, document protection, and insurance.

PREPARING FOR A DISASTER







The first step in preparing necessary resources is to determine the products and services your organization needs to address disasters. Whether your organization operates an application with sensitive information that needs to fail over to a disaster recovery zone in a major power outage, or you work for a municipal government that needs physical supplies to help the community recover after a weather event, it's in your best interest to identify everything you could need and connect with suppliers that can meet those needs.

Once you identify potential preparation materials and recovery/cleanup materials, contact your suppliers ahead of time and tell them what disaster response supplies you require. You should also work directly with these suppliers to assess whether the supplier has their own distribution network, uses their regular business structure to support disaster efforts, and can scale their communication and services based on disaster size. In addition, consider establishing disaster response performance expectations with your suppliers at pre-negotiated rates.



PRACTICING FOR A DISASTER

Your organization has people that are counting on you, whether you are a university with thousands of students, a nonprofit organization serving your community, a corporate business with remote and inperson employees, or a property management company with multiple buildings and residents. The safety of any individual person or community that is affected by your organization should be your first priority, and it's vital to practice your EOP to ensure that the documented methods of responding to disasters are actually effective.

Your EOP should be thoroughly reviewed on an annual basis. These reviews should accomplish two goals: reinforcing the mission-critical tasks that are defined in the plan and identifying and updating any gaps or outdated processes. In addition to reviewing the plan, your organization should also gather stakeholders annually to practice the plan and ensure that everyone is aware of their designated responsibilities.



Aside from training personnel on their roles, other benefits of testing your plan and conducting plan exercises include reinforcing knowledge of the plan, evaluating processes and team skills, ensuring compliance with relevant regulations, and promoting awareness of the emergency management program. Testing your EOP can look like discussion-based tabletop exercises, scenario-driven exercises in a simulated environment, or full-scale on-location exercises conducted by public agencies.

Another essential way to test your organization is by incorporating proactive cybersecurity strategies into your processes. Cyberattacks are ever on the rise, and penetration testing, adversary emulation, and red teaming are all methods that organizations can employ to identify areas of concern. If any vulnerabilities or areas for improvement are identified, take immediate action to secure your virtual environment and prevent malicious actors from breaking into your systems. In addition, consider conducting real-world tests of your organization's ability to prevent data compromise.

how supply needs would be met in a disaster. Practicing the EOP in this way is essential in demonstrating how and when supplies can reach disaster-impacted areas.

For many organizations that operate out of a physical office facility, equipment like fire extinguishers, sprinklers, generators, thermostats, water sensors, and other safety-related items are needed to mitigate risks stemming from climate and weather events, fires, and water damage.
